

**COWBOY BILL'S CORNER:** There are just five and one-half months left to meet the goals we set for 1987-88. We need a renewed "push" to finish the tasks we undertook last July. To help make the push I will have a club assembly of board members and committee chairpersons at 5:00 p.m. on Monday February 1, 1988 at my office at 2317 Broadway, Suite 240, R.C.

The board has devised a 5 for 1 plan to make our **Membership Roundup Month in February** both productive and enjoyable. The idea is to join groups of five Rotarians together and have each group of five find one new potential member. Membership Chairman Mario Ercolini will be choosing the teams.

February is also designated 100% attendance month. We will again use the "Buddy" system to assure that everyone gives their best effort to be 100%.

**6 MILLION A.I.D. GRANT TO POLIO PLUS CAMPAIGN FUND.** A Child Survival matching grant of US \$6 million from the United States Agency for International Development (A.I.D.) has given a big boost to the Polio Plus Campaign Fund which now exceeds US \$60 million. This means that half the targeted \$120 million has been reached.

A five year agreement between A.I.D. and Rotary, calls for \$2 million during the first year and \$1 million for each of the following years. The agreement, which was signed by President Keller and Jay F. Morris, Acting Administrator of A.I.D., on 18 September, 1987, was witnessed by U.S. Senator Robert Dole of Kansas.

The United States has thus become the fifth major nation to officially give financial support to Polio Plus. Other grants have been received from the United Kingdom, Canada, Federal Republic of Germany and Norway.







May 22-25 is the Rotary International Convention in Philadelphia. Mark your calendar and there will be more on the Convention later.





With sponsor BETH taking care of the introductions, Pres. BILL took care of the formalities in another of those happy occasions - the induction of a new member. Our new RC Rotarian is ABEL SANCHEZ, photographer and owner of the Golden Images Studio on Woodside Road. On hand to enjoy in this always big event was ABEL's lovely Rotariann Janet. Welcome!

Program Chairman for the month, JUDY SMITH, introduced our speaker for this first Tuesday in March, Ms. Dori Dysland, M.A., Program Director of the Alcohol and Drug Recovery Center at Sequoia Hospital

Ms. Dysland spoke to the general problem of chemical dependency, the biggest element of which is alcoholism, and then to the specific current and major crisis involving the growing use and abuse of cocaine.

Unfortunately perceived by many as a recreational drug, the American College

of Emergency Physicians has seen fit to issue a stern warning to potential users that cocaine is in fact a highly dangerous drug.

And what a fine show it was! That's right, for a short period you're going to read to a class from a book that you can either bring or they'll provide - just like you've read to your own children or grandchildren or were read to when you were young.

It's biggest plus, by the way, appears to be the suggestion that neither San Francisco nor Santa Clara - the other two possible sites - presently appear to be viable alternatives.

An enlightening and interesting exposition for all, whether you've got a problem "wearing it" or not. And if you've got to drop some of that excess it sounds as though with some knowledgeable care in choosing your diet you don't have to "starve" them off. Do it right and they won't return.


CHARLES NORRIS will be your finemaster - don't know, though, if he'll try to do it with a kettle and a bell. Oh well, one way or the other...



SID delivered the medicine donated by District Relief International to AYO who then arranged to transport it to Nigeria.

The Nigerians gave us a "Wish List" of materials for the ongoing care that we hope the eye camp will generate. Since our return Direct Relief International has offered SID most of the items on the wish list (Approx. value \$300,000) for the small cost of processing and transportation.

This could be the opportunity RWC Rotary has been looking for in developing a World Community Service Project.





FOR JULY make some notes on your calendar. This is the time when we always have some changes in our meeting place and as of now this is how it looks.


July 5: We'll be here at the church for a Club Assembly. And be sure to be here 'cause Pres. Elect BDB needs a full house to get the year off to a good start.
