ROTARILY: Vocational Service's role in our Club. Vocational service has acquired renewed importance as an Avenue of Service over the past two years. Now more than ever, Vocational Service is a responsibility of our club as a whole. This is a change from the focus in the past, which emphasized the personal contributions we make in our vocations and in the workplaces. This change means that as a club we must work to develop service projects that promote high ethical standards in the workplace, that assist the vocational needs of people -- young and old -- in our community, and employ the vocational talents of all our club members.

OBSERVE WORLD UNDERSTANDING MONTH: It's not too early to start thinking about February, World Understanding Month. Now that many of the repressive political structures of Eastern Europe seem to be on courses charted toward democracy we must hope that the old prejudices of thenic rivalry will give in to true cooperation and understanding.

The majority must not trample the rights of minorities. Rotary has a great opportunity to lead by its example of friendship among nations, races, and religions.

Rotary offers many ways to cut through the often artificial barriers that separate people, Such programs as Group Study Exchange, Youth Exchange, and Friendship Exchange bring together people from different cultures and help them to see how minor their their differences really are. The Rotary Foundation Scholarship program, in which students study a country other than their own, also facilities this kind of cross-cultural understanding.

International Service projects play an important role in Rotary's work for world understanding. Destitute people have little energy or inclination to seek peace. By improving the standard of living in developing nations, in urban slums, and in depressed rural areas, Rotary clubs help to create an environment that will inspire all people to work for the preservation of the planet.

And according to DR. JEDD, the prospects today remain grim and forbidding unless some current version of the Marshall Plan can come about to rescue their recovery from the communist collapse.

As an interesting, postscript it might be noted that once again after all these years there <u>is</u> a Rotary Club in Warsaw - now boasting all of 25 members. There was a nice feature article about it in the <u>Wall Street Journal</u> issue of January 10.



Among the six Jesuits slain in El Salvador last November 16 were the then President of UCA and the academic vice president who FR. BEIRNE will replace. A personal friend of the slain Jesuits at UCA, FR. BEIRNE will shortly be travelling to El Salvador for the sixth time. His knowledge of that troubled area should provide a most interesting commentary in view of next week's speaker being the Consul General of El Salvador.

Your finemaster today is none other than that retiring gent PETE HUGHES and who knows what that may lead to.

LAST WEEK: After calling on PDG SID to lead the chorus in a rousing introduction, MEL ANISMAN to lead the pledge and PETE HUGHES to give the invocation, Pres. BOB attended to the ceremonies of past presidents' day by introducing a fine bunch of flower bedecked past presidents who were able to join in on the day's festivities. In order of their service and introduction were MESSRS. SCHUTZ, KECKLY, BOSTWICK, PARCELL, ESSON, BERGLER, DURKIN, MACLEOD, BERLIN, DOOLEY, HUGHES and RUTHERFORD. And how nice it was to see the many Rotarians (now spouses all) who were able to join in the occasion.

Yes, it's no misprint, it was JOHN ESSON who fortuitously dropped by on a visit from his present home in Morrison, Colorado.

BOB, or whomever, it was noted that accommodations are going to be needed to care for the GSE Team of four ladies from Sweden who will be visiting the area from April 22 to 26. Make it known if you are able to offer any help. These visitations are always an interesting and enjoyable experience.

Pres. BOB also notes that there will be a Club Assembly on March 20 to review recommendations by Board Subcommittees on fund raising and the handling of various club fees. Acknowledging that it hasn't been enforced of late, Pres. BOB did point out that it is a club policy to charge members (the luncheon price) for missed meetings not made up. 

According to Senator KOPP, however, the funds so raised <u>cannot</u> be spent, and therefore no solution, without the passage of Prop. 111 for which he strongly urges a yes vote.

An interesting and impressive discussion of a most important issue.



Because of his and other AIDS tragedies within the family of the Los Altos Rotary Club, that club has now undertaken a major project to develop an AIDS educational program in the form of a professional video tape for use world-wide, a sensitive film that will personalize the statistics of AIDS and capture the emotional trauma of the disease in a compelling and dynamic way.

In view of the great cost of this project - some \$75,000, the Los Altos Club is soliciting support by donations from individual Rotarians and Rotary Clubs. If you can help, please mail your contribution to:
