## Rotary Global Grant Waste Water Treatment Project Santuario De Olon Community MANGLARALTO, SANTA ELENA, ECUADOR

**BACKGROUND:** About 1200 people belong to the Santuario De Olon Community of Manglaralto, Santa Elena located on the west coast of Ecuador. This community was founded by Father Othmar Staheli in 1972 with a Christian mission to provide fresh water, food, housing and healthcare to the Community. The welfare of children has been a particular focus of the mission. Current services provided include:

- A boarding school for 70 homeless children aged 0-12 years
- A grade school that serves these children and an additional 600 of the areas poorest children
- A nursery for 60 infants
- A health clinic that provides low to no cost care to 500 local residents per month



**NEED:** Santuario De Olon generates approximately 100 cubic meters per day of domestic wastewater that is currently discharged to a collapsed primary septic tank and infiltration field. Both are in desperate need of replacement. Failure to do so will have severe health and environmental consequences.

**GLOBAL GRANT PROPOSAL:** The Rotary Club of La Puntilla, located in Guayaquil Ecuador has organized a Global Grant proposal to replace this waste water treatment system. La Puntilla has conducted detailed engineering studies and outlined a project budget. The total budget for this project is \$61,236. La Putilla has already secured commitments of \$41,400 from their Club and others in District 4400 leaving \$19,796 in funding still needed from an international sponsor. The Rotary Club of Marin Evening has agreed to be this sponsor; however, it needs support from other international Clubs. Marin Evening has successfully worked with La Puntilla on matching grant projects in the past, including providing a mechanical cow to Santuario De Olon several years ago. This cow is still providing soy milk to the children.

## An Excerpt from “Rotarians in our Twenties and Thirties”

“Generation Y is about a globally connected world. There’s never been a time when members of this generation were not connected to people on the other side of the planet.” Still, she notes, they’re not naturally drawn to Rotary; only 11 percent of members worldwide are under 40. 
